Please note that as of January 1, 2017, (with the passage of AB 2890), WWOCP can accept for-profit coursework as long as it is in math, wastewater, biology, chemistry, engineering, or physics. This includes coursework completed before January 1, 2017. Applicants can submit completion certificates to the WWOCP at any time for educational point review. The WWOCP is not able to allot educational points for safety coursework.

You do not have to pay an application fee nor be registered so that coursework can counts toward educational points for the WWOCP.
